Campus Population--Students, Faculty, and Staff

- In total, there were 45,107 people employed by or attending classes at UCSD in October, 2006 (Table 1).
- 53% of the people employed or attending classes at UCSD were female in October, 2006. There is an equal proportion of male and female students, but about 12% more employees are female than male (Table 1).

Students

- In Fall, 2006, there were 26,583 registered students, excluding health science residents (Table 2). This is a 3.5% increase from the previous fall.
- 32% (8,838) of all students live on campus or in campus affiliated housing (Table 3).

Faculty and Staff

(Emeriti faculty and other employees on recall status are included; student workers are excluded.)

- In October, 2006, UCSD employed 18,524 people (Table 4).
- 63% (11,821) of those employed by UCSD work in the La Jolla campus areas, which include East Campus, Salk Institute, Scripps Institution of Oceanography, School of Medicine, the VA Hospital, and West Campus (Table 4).
- An additional 27% (5,003) work at the Hillcreast Medical Center area (Table 4).
- Women make up a higher percentage of the professional and support employees (66%) and a lower percentage of the academic employees (33%) than do men (Table 5).
- 27% (5,052) of all campus employees are employed in academic positions (Table 6).
- Of the employees working at the La Jolla campus or the VA Hospital, 25% (2,966) live within 5 miles of their job locations and 75% (9,060) live within 15 miles of their job locations (Table 7).
- 53% (2.637) of those working at Hillcrest live within 10 miles of their job location (Table 8).
- 61% (11,111) of all employees live within the City of San Diego (Table 9).
- 35% (6,410) of all employees for whom address information is available live in seven San Diego areas: University City, La Jolla, Chula Vista, Mira Mesa, Carmel Valley, Mission Hills, and North Clairemont (Table 10).
